WHEREAS, under Paul's leadership the City increased participation with the Metropolitan Unified Fiber Network (MUFN) resulting in connectivity to most City facilities. In his role as Chair of the MUFN Oversight Committee, he has strengthened relationships with other governmental entities and private sector partners; and
