Fiscal Note

The proposed resolution creates a new Employee Assistance (EA) Specialist 3 classification and recreates two EA Specialist 2 positions into the new classification. Annualized costs from the new classification could range from \$14,000 to \$21,000. Actual costs will depend on the employee's placement among the EA Specialist 1, 2, and 3 classifications and depends on their experience, education, and obtained licenses. Costs in 2023 will be accommodated within the Employee Assistant Program's Adopted Operating Budget and no additional appropriation is required.
