**Fiscal Note**

In the adopted 2017 capital budget Engineering Pedestrian/Bicycle has budgeted \$2.31 million for the repair and installation of sidewalks throughout aldermanic districts 15 and 17. The proposed resolution approves plan documents for these 2017 sidewalk program costs at a total estimated cost of \$410,000. Funding is provided by GO Borrowing and special assessments.

PREAMBLE

This citywide program provides repairs, replacements, and new installations of sidewalk, curb & gutter, and concrete pavement.

BE IT RESOLVED,

- 1) That the plans and specifications for Sidewalk, Curb & Gutter, and Concrete Pavement Patches, Citywide Installation and Repair - 2017 , be and are hereby approved.
- 2) That the Board of Public Works be and is hereby authorized to advertise and receive bids for said project.
- 3) That the Mayor and City Clerk are hereby authorized to sign and grant easements or right-of-way release or procurement documents, maintenance agreements or encroachment agreements, as necessary and grant or accept dedication of lands and/or easements from/to the Developer/Owner for public improvements located outside of existing public fee title or easement right-of-ways.
