## **Fiscal Note**

The proposed resolution authorizes an agreement between the City of Madison and Madison's Central Business Improvement District (BID) and/or its fiscal sponsor for programming at locations on State Street and the Capitol Square. The Economic Development Division's 2024 Adopted Operating Budget includes \$62,225 to support the (BID) programming (Munis account 63221-54810). No additional City appropriation is required.

#### **Title**

Authorizing a \$62,225 contract with Madison's Central Business Improvement District (BID) and/or its fiscal sponsor to fund the continuation of the Downtown Activities Program focused on existing plazas around the Capitol Square and State Street (District 2, District 4, District 8)

## **Body**

WHEREAS, the City of Madison and Madison's Central Business Improvement District (BID) have been partners in implementing a successful placemaking and activities programming at the Top of State Street and other public spaces throughout the Downtown during each summer since 2015; and

WHEREAS, this partnership has created the "Summer in Your City" program that includes, but is not limited to the popular programs such as "Kids Create at the Top of State", "Summer in Your City Café" and the "Madison Night Market", among other activities; and

WHEREAS, 2020-2023 continued to be difficult years for downtown businesses and the BID was able to successfully pivot many of their planned programming activities into virtual events, and other supportive activities throughout the district, and

WHEREAS, the City would like the BID to continue to reinstate in-person programming activities to the extent possible at the "Top of State" as well as other public open spaces and plazas along State Street and the

Capitol Square, including, but not limited to, Rotary Plaza, Lisa Link Peace Park, North Frances Plaza, and the intersection of State Street Mall and the Library Mall; and

WHEREAS, the Common Council included funding in the 2024 Operating Budget that \$62,225 should be directed towards continued programming of these spaces downtown.

NOW THEREFORE BE IT RESOLVED, that Madison's Central Business Improvement District, working with cultural partners such as the Madison Public Library, Wisconsin History Museum, Overture and others, will develop programing and placemaking efforts to activate park, plazas and other public spaces along State Street and the Capitol Square as described above, throughout the summer and into fall of 2024.

BE IT FINALLY RESOLVED, that the Common Council authorizes the Mayor and City Clerk to enter into a contract for up to \$62,225 between the City of Madison and Madison's Central Business Improvement District or its fiscal sponsor with terms as approved by the Department of Planning and Community and Economic Development Director and City Attorney, to administer the 2024 Downtown Activities Program.
