1. That said sanitary sewer, storm sewer, and street improvements (including bituminous surface pavement) be and are hereby accepted.

2. That the street improvements, **including the bituminous pavement**, on the following streets be and are hereby accepted:

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 11214 \$8,850.00 for a useful life of 40 years.
