**Title**

Approval to accept a Homeland Security/2007 Metropolitan Medical Response System OJA Grant for \$250,401.

**Body**

The City of Madison Fire Department has received notification from the State of Wisconsin Office of Justice Assistance as to the award of a grant for the Metropolitan Medical Response System (MMRS) in the amount of \$250,401. The grant covers preparing for response to Weapons of Mass Destruction (WMD) and mass casualty incidents.

The grant covers the metropolitan area which includes Dane County. The focus area for this program are interoperable communications, medical supplies, training, exercises, mass care, mass casualty protocols with the Milwaukee program, patient tracking and volunteer utilization.
