Resolution that the positions #1855 (R. Crocker), #1890 (N. Malacara), #1881 (T. Trieloff), #3161 (vacant), and #1873 (vacant) of the Water Meter Mechanic 1-3 series in Compensation Group 16, Ranges 9 / 11 / 13 (respectively); and the position #1868 (J. Weaver) of the Water Meter Reader classification in Compensation Group 16, Range 9 in the permanent salary detail of the Water Utility budget are repealed and recreated as Field Service Representatives (FSR) 1-3 in the same ranges and the incumbents be reallocated to the new classifications, thereof.

Resolution that the position #1850 (J. Brumley) of the Water Meter Reader (LTE) classification in Compensation Group 16, Range 9 in the permanent salary detail of the Water Utility budget is repealed and recreated as a Field Service Representative 1 (LTE) in the same range and the incumbent be reallocated to the new classification, thereof.

Resolution that the position #1853 (A.Mazarra) of the Water Meter Mechanic Leadworker in Compensation Group 16, Range 15 in the permanent salary detail of the Water Utility budget is repealed and recreated as a Field Service Leadworker in the same range and the incumbent be reallocated to the new classification, thereof.
