#### Title

Authorizing the Mayor and City Clerk to enter into an agreement with Gary Brown Roofing Corporation to provide construction roofing services for the Traffic Engineering Building Unit 'A' located on Sayle Street.

WHEREAS on August 16, 2006, the Board of Public Works approved the motion to declare the replacement of the roof at 1120 Sayle Street (Traffic Engineering Operations) Building A an emergency and to suspend public works bidding; and,

WHEREAS the scope of this work includes furnishing material, labor, and equipment to install a new roof system on the existing building. The work includes preparation of existing roof areas and installation of new TPO roof membrane, over new polystyrene insulation for increased energy efficiency, on existing fluted metal roof deck; and,

WHEREAS the total contract compensation for construction roofing services for Gary Brown Roofing Corporation is \$56,950.00; and,

WHEREAS the 2006 Capital Budget includes funding for construction services in EP01-58401-810416 (Traffic Engineering Building Improvements) \$38,000 available and CS53-58401-810553 (Energy Efficiency Improvements) \$83,000 available, a building contractor must be hired to construct this project; and,

WHEREAS the Mayor and City Clerk are authorized to sign a contract with Gary Brown Roofing Corporation for the

NOW, THEREFORE BE IT RESOLVED that the Common Council hereby authorizes Mayor and City Clerk to enter into an agreement with Gary Brown Roofing Corporation to provide construction roofing services for the Traffic Engineering Building Unit 'A' located on 1120 Sayle Street.
