The cost for the remainder of 2008 is approximately \$2,739 (or \$3,744, including benefits) and is available in the Monona Terrace budget. The projected annualized cost is \$2,908 (or \$3,978, including benefits). Note: Cost estimates incorporate the prior maximum sales incentives paid (15%), which will not be available in Compensation Group 18.
