The \$30,000 funding required by this agreement in 2009 is included in the Miscellaneous Appropriations section of the 2009 Operating Budget.

Title

SUBSTITUTE - Authorizing the Mayor and City Clerk to execute an agreement with Martin Schreiber & Associates, Inc. for direct state government lobbying services for 2009.

Body

WHEREAS, the City's 2009 budget included \$30,000 for a contract for direct state government lobbying representation services; and

WHEREAS, the City prepared a request for proposal for direct state government lobbying representation services; and

WHEREAS, Martin Schreiber & Associates, Inc. submitted a response to the Request for Proposals; and

WHEREAS, Martin Schreiber & Associates, Inc., after review of the submitted proposals, has been recommended to provide consulting services to the City;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Clerk be and are hereby authorized to execute an agreement with Martin Schreiber & Associates, Inc. for direct state government lobbying services

for 2009, with an option to extend the services for two additional one-year terms if funded by the 2010 and 2011 annual City budgets respectively.

BE IT FINALLY RESOLVED, that such agreement include a provision that Martin Schrieber & Associates, Inc. meet with the Common Council Organizational Committee at least twice annually.
