### Fiscal Note

The proposed resolution would eliminate the classification of Disability Rights and Services Program Coordinator in Compensation Group 18, Range 8, and create the new classification of Disability Rights and Services Program Coordinator in CG 18, Range 10. It would also recreate one existing Disability Rights and Services Program Coordinator (0076) to the new position. The annualized cost of the proposed reclassification is \$15,998 (including benefits). The increase will be absorbed by the 2020 Civil Rights Operating Budget. No additional appropriation is required.

### Title

Delete the classification of Disability Rights and Services Program Coordinator in CG 18, Range 8 and create a new classification of Disability Rights and Services Program Coordinator in CG 18, Range 10. Recreate position number #0076 to a Disability Rights and Services Program Coordinator (CG18, R10), and reallocate incumbent J. Glozier into the new CG and Range.

### Body

Resolution deleting the classification of Disability Rights and Services Program Coordinator (CG 18, R8) and

create a new classification of Disability Rights and Services Program Coordinator in CG 18, Range 10.

Be it further resolved that position #0076 is recreated as a Disability Rights and Services Program Coordinator in CG18, R10, and current incumbent, J. Glozier, is reallocated to the new position, in the Civil Rights operating budget, thereof.
