Referred for Introduction

WHEREAS the Common Council adopted Ordinance 2091 on August 11, 1966 to establish the Official Map for the City of Madison for parts of the City of Madison located in Sections 27, 28, and 33, T8N R10E to map various future streets/ highways, parkways, and greenways in the portion of the existing and future City generally bounded by E Washington Avenue on the north, Interstate 39/90/94 on the east, Mendota Street on the west, and Wisconsin and Southern Railroad corridor on the south; and

WHEREAS the *Greater East Towne Area Plan* was adopted by the Common Council by Resolution 22-00144 (ID 68802) on February 22, 2022 as a supplement to the *City of Madison Comprehensive Plan* to guide future land uses, street networks, transit facilities, bike facilities, and open space investments within the planning area; and

WHEREAS the *Greater East Towne Area Plan* recommends that a network of streets be implemented to serve planned development in the planning area, including on the property commonly known as Great East Towne Mall area as well as on surrounding properties within the planning area, including the extension of Parkside Drive south to intersect and terminate at Mendota Street; said reservation being 66 feet wide; and

WHEREAS the proposed amendments to the Official Map do not call for reservations to be made through existing buildings at this time;

NOW THEREFORE BE IT RESOLVED, the City Of Madison hereby amends the City of Madison Official Map to reserve lands for Proposed Streets and Highways under Section 16.25(6) of Madison General Ordinances and under Wis. Stats. ss. 62.23(6)(c), as shown on the attached map in Exhibit A and as legally described in attached Exhibit B.

BE IT RESOLVED that the Streets and Highways to be reserved with this amendment are consistent with the recommendations in the *Greater East Towne Area Plan*.

BE IT RESOLVED that notice of this amendment has been provided pursuant to the requirements under Wisconsin Statutes Sec. 62.23(6) and Section 16.25(6) of Madison General Ordinances.
