Title

Amending Section 34.01(2)(c) and creating Section 34.19(4) of the Madison General Ordinances to limit applicability so as not to preclude flexibility in street width and to not conflict with the applicability provisions of the One and Two Family Dwelling Code and the Commercial Building Code.

Body

The Common Council of the City of Madison do hereby ordain as follows:

1. Subdivision (c) of Subsection (2) entitled "Application of Code" of Section 34.01 entitled "General Provisions" of the Madison General Ordinances is amended to read as follows:

"(c) Except as provided herein, this code applies to each building and premises, public or privately owned and public thoroughfares located within the City of Madison."

2. Subsection (4) entitled "Application" of Section 34.19 entitled "Fire Apparatus Access Roads" of the Madison General Ordinances is created to read as follows"

“(4) Application. This section shall apply only to places of employment as defined in Sec. 101.01(11), Wis. Stats., and public buildings, as defined in Sec. 101.01(12), Wis. Stats., with the exception of multi-family dwellings as defined in Sec. 101.971(2), Wis. Stats.”
