- 1. That the street improvements, **including the bituminous pavement**, on the following streets be and are hereby accepted:
 - Flagstone Drive from the westerly lot line of Lot 60 to Trevor Way
 - Bedner Road from Flagstone Drive to the northerly lot line of Lot 76
 - Trevor Way from the southerly lot line of Lot 29 to the northerly lot line of Lot 42
 - · Red Granite Road from Jeffy Trail to Bedner Road
 - Jeffy Trail from the southerly lot line of Lot 74 to the northerly lot line of Lot 75
