Fiscal Note

The proposed resolution authorizes amendment #3 to the existing Architectural / Engineering design services contract (#9017) for the Tenney Park Beach Shelter project. The contract amendment would add \$7,500.00 to the existing authorized contract amount of \$79,870 for continued services to be provided for plan updates, updated cost estimate, bidding and construction administration phases of the project for a revised contract total of \$87,370. This resolution further authorizes the contract total to be increased up to a total \$90,000 to cover minor contingencies. Budget authority is available in the 2023 Adopted Capital Budget (Munis # 13343). Title

WHEREAS, The City of Madison has Targeted Business Enterprise (TBE) programs in place to ensure Small, Minority, & Women Business Enterprises are afforded the maximum feasible opportunity to compete in City contracting and procurement; and

WHEREAS, Individuals with purchasing authority can help level the playing field and advance contracting equity by utilizing these companies; and

WHEREAS, Destree Design Architects, Inc. is a City of Madison certified local business (offices at 222 West Washington), a City of Madison certified Small Business Enterprise (SBE), and a City of Madison certified Women Business Enterprise (WBE).

WHEREAS the parties, the City of Madison ("City") and Destree Design Architects, Inc. ("Architect") entered into a contract for the purchase of professional architectural design services for the Tenney Park Beach Shelter project on January 25, 2021 (RES-21-00066, File ID 63177); and,

WHEREAS, the contract amendment for this resolution is to address extra services required by the City after the project was delayed in 2021; and,

WHEREAS additional services required by the City include an updated Estimate of Probable Cost, updating construction drawings and specs for bidding, including upgraded electrical circuits, additional pump room wall heater and outlet; and,

WHEREAS extra services include updated costs associated with the extended project schedule.

NOW THEREFORE BE IT RESOLVED, that the Common Council hereby authorizes the Mayor and City Clerk to execute Amendment #3 to the Contract between the City of Madison and Destree Design Architects, LLC. in a form to be approved by the City Attorney, to provide additional professional architectural and engineering design services for the work as described above.

BE IT FURTHER RESOLVED, that the contract not to exceed total be increased a total \$90,000 for Amendment #3 and to cover other minor contingencies.
