Fiscal Note

No additional appropriation is required in 2010, as the position is currently vacant, and any actual costs will be met by the management of salary savings. A maximum of \$5,150 (or \$7,122, including benefits) would be managed in 2010 if the position is filled for the entire year. Over the long run, additional annual salary costs of \$7,800 (or \$10,787, including benefits) may be anticipated. Funding as appropriate will be requested in 2011 and subsequent year operating budgets.
