Restoration of any damage within right of way will be completed in accordance with the City of Madison's standard specifications. All damaged sidewalk slabs will be replaced with 5" lift concrete. All damage done to grass will be restored with a four inch covering

of black dirt and seed specified by the City of Madison. All restoration required within the traveled portion of the roadway will also be completed in accordance with the City of Madison's standard specifications.
