Body

That the bituminous surface street improvements on the following streets be and are hereby accepted:

- Watts Road from the West line of Lot 277 to Old Timber Pass (West)
- Watts Road from Old Timber Pass (West) to Old Timber Pass (East)
- Watts Road from Old Timber Pass (East) to Sugar Maple Lane
- Watts Road from Sugar Maple Lane to Noble Oak Run
- Watts Road from Noble Oak Run to the East line of Outlot 4
- Old Timber Pass (West) from 212' North of Quiet Leaf Drive to Sleepy Pine Ridge
- Old Timber Pass (West) from Sleepy Pine Ridge to Watts Road
- Old Timber Pass (East) from 212' North of Quiet Leaf Drive to Sleepy Pine Ridge
- Old Timber Pass (East) from Sleepy Pine Ridge to Watts Road
- Sleepy Pine Ridge from Old Timber Pass (West) to Old Timber Pass (East)
- Sleepy Pine Ridge from Old Timber Pass (East) to Sugar Maple Lane
- Sleepy Pine Ridge from Sugar Maple Lane to 98' SE of Sugar Maple Lane
- Sugar Maple Lane from the South line of Lot 320 to Sleepy Pine Ridge
- Sugar Maple Lane from Sleepy Pine Ridge to Watts Road
- Sugar Maple Lane from Watts Road to the North Plat Line

- Noble Oak Run from Sleepy Pine Ridge to Watts Road
- Hazy Sky Parkway from the West line of Lot 378 to Old Timber Pass
- Hazy Sky Parkway from Old Timber Pass to 165' Est of Old Timber Pass
- Old Timber Pass from 66' South of Hazy Sky Parkway to Hazy Sky Parkway
- Old Timber Pass from Hazy Sky Parkway to Quiet Leaf Drive
- Old Timber Pass from Quiet Leaf Drive to 181' North of Quiet Leaf Drive
- Old Timber Pass (West) from 181' North of Quiet Leaf Drive to 299' North of Quiet Leaf Drive
- Old Timber Pass (East) from 181' North of Quiet Leaf Drive to 299' North of Quiet Leaf Drive
- Quiet Leaf Drive from the West line of Lot 290 to Old Timber Pass
- Quiet Leaf Drive from Old Timber Pass to 159' East of Old Timber Pass

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 11934 by \$ 2 4 3 , 8 9 9 . 7 9 for a useful life of 40 years.
