Fiscal Note

This is an extension of a previous agreement and provides for the reimbursement by Edgewood College of all fixed route and ADA paratransit trips provided by Metro Transit to Edgewood College students and employees during the contracts term. Fixed Route trips shall be reimbursed at the rate of \$.88 per trip, consistent with the current TPC-approved fare tariff. There would be no net fiscal impact on the City General Fund or on the transit utility operating budget.
