The original contract amount was \$300,000. This amendment will increase the total contract to \$352,000. Funding is included in the Water Utility 2005 Adopted Operating Budget in Acct. No. EW01-54901-640000.

WHEREAS, Madison Water Utility has retained Black and Veatch Corporation of Kansas City, Missouri to complete an update of the Utility's Water Master Plan and to prepare a Facilities Management Plan; and WHEREAS, work has progressed and evolved on the project over the last 24 months, unanticipated additional costs have been incurred due to project, additional tasks have been identified and refined, and WHEREAS, a revised scope of services and additional fee has been negotiated with Black and Veatch Corporation. NOW THEREFORE BE IT RESOLVED, that the Mayor and the City Clerk are authorized to execute Amendment No. 1 to the Professional Services Agreement with Black and Veatch Corporation not to exceed \$52,000 for additional services.
