The proposed resolution authorizes the award of Public Works Contract No. 8128, Hilldale Way - Maple Terrace - University Avenue Traffic Signal Assessment District. The estimated cost of the project is \$276,890. The Traffic Engineering 2018 Capital Budget includes \$820,000 for Traffic Signal Installation (Munis project 10427). Funding is available in the minor projects listed on the attached.
