Body

Preamble:

The scope of services for the Breese Stevens architectural contract provides for complete plans and construction services for structural repairs, but limits interior design work to consideration of design options and schematic design for reuse of interior spaces. After review of the design options, the Parks Division has selected a program that will combine basic structural repairs with interior upgrades that best meet the need for accessibility and useability of the structure. Additional design fees of \$40,692 are required to provide plans and specifications for the expanded program, to be bid out for Fall 2007 construction.

NOW THEREFORE BE IT RESOLVED, that the Mayor and City Clerk are hereby authorized to execute an amendment to the contract for purchase of services with Isthmus Architects, Inc. for the Breese Stevens Stadium renovation.
