Fiscal Note

The proposed resolution creates a career series ladder for the Asset Manager classification. The annualized cost of the proposed reclassification is \$9,357 (including benefits). The impact on the 2019 budget is approximately \$2,339. Costs associated with the reclassification will be absorbed within the agency's 2019 budget.

Create a new classification series of Asset Manager 1 and 2 in CG18, R10 and CG18, R12, respectively, and delete the classification of Asset Manager in CG18, R10.
