### Title

Creating Section 28.022-00626 of the Madison General Ordinances to change the zoning of various properties located in the northeastern quadrant of the Acacia Ridge subdivision generally addressed as 606-614 Little Dove Trail and 9205-9229 Silver Maple Drive, 1<sup>st</sup> Alder District, from TR-C3 (Traditional Residential-Consistent 3) District to TR-P (Traditional Residential-Planned) District.

### Body

DRAFTER'S ANALYSIS: This ordinance amendment rezones various properties located in the northeastern quadrant of the Acacia Ridge subdivision generally addressed as 606-614 Little Dove Trail and 9205-9229 Silver Maple Drive from TR-C3 (Traditional Residential-Consistent 3) District to TR-P (Traditional Residential-Planned) District to accommodate Acacia Ridge Replat No. 5.

The Common Council of the City of Madison do hereby ordain as follows:

1. Map Amendment 00626 of Section 28.022 of the Madison General Ordinances is hereby created to read as follows:

"28.022-00626. The following described property is hereby rezoned to TR-P (Traditional Residential-Planned) District.

A parcel of land located in the NE1/4 of the SE1/4 of Section 28, T7N, R8E, City of Madison, Dane County, Wisconsin more particularly described as follows:
