\$2,750,000 was previously authorized for this project with this additional \$500,000, the total cost of the project will be funded as follows: (Sanitary Sewer Utility) Acct. No. ESO1-58011-810322-00-53W0147 \$1,650,000.00, (Storm Sewer Utility) Acct. No. ESTM-58011-810322-00-53W0147 \$825,000.00, and (Landfill Remediation) Acct. No. CB53-58011-810322-00-53W0147 \$775,000.00. Additional funding will be from Landfill Remediation reserves. There will be no additional General Obligation Debt. There is no anticipated impact upon the tax levy or cost controls.
