Amending Section 2.01(1) of the Madison General Ordinances to adjust the Common Council meeting dates for November and December, 2005.

Body

DRAFTER'S ANALYSIS: This ordinance changes the Common Council meeting dates for the months of November and December, 2005 in order to provide adequate time in the budget process for the Board of Estimates to meet and consider budget amendments and prepare their report back to Council.

The Common Council of the City of Madison do hereby ordain as follows:

Subsection (1) of Section 2.01 entitled "Meetings" of the Madison General Ordinances is amended to read as follows: (1) The stated meeting of the Common Council shall be held in the Council Chambers on the first and third Tuesdays of every month at 6:30 p.m., except in August and December the Common Council will meet only on the first Tuesday; provided, however, that a meeting shall be scheduled for November 16, 2004 for the purpose of adopting the 2005 Capital and Operating Budgets; that the regularly scheduled meeting of February 15, 2005 shall be rescheduled to February 22, 2005; that the regularly scheduled meeting of April 5, 2005 shall be rescheduled to March 29, 2005; that the regularly scheduled meeting of April 19, 2005 shall begin at 12:00 noon; that the regularly scheduled meeting of October 4, 2005 shall be rescheduled to October 11, 2005; <u>that the regularly scheduled meeting of November 1, 2005 shall be</u> <u>rescheduled to November 8, 2005;</u> and that a meeting shall be scheduled for November <u>815</u>, 2005 for the purpose of adopting the 2005 Capital and Operating Budgets; that the regularly scheduled meeting of November 15, 2005 shall be

rescheduled to November 29, 2005; and that the regularly scheduled meeting of December 6, 2005 shall be rescheduled to December 13, 2005."
