The City of Madison Engineering Division is proposing to conduct watershed and flood studies for the west and near west sides as a result of extreme rain events over the past several years. The City entered into an agreement with MSA Professional Services, Inc for engineering services related to flooding evaluation in the Willow Creek watershed (RES-20-00361).

The City Engineer requested additional engineering services and recommend that they be undertaken by MSA Professional Services, Inc. for the Willow Creek Watershed Study as defined by the Attached Scope of Work entitled "Willow Creek Watershed Study - Amendment #4".
