WHEREAS, Victor "Vic" Wahl first joined the Madison Police Department as an officer in 1991; and,

WHEREAS, now Assistant Chief Wahl has served in many capacities within the MPD to include the promoted positions of Sergeant beginning in 1999, Lieutenant beginning in 2002, Captain beginning in 2008, and Assistant Chief beginning in 2017; and,

WHEREAS, on September 30, 2019 former Madison Police Department Chief Mike Koval retired and,

WHEREAS, Assistant Chief Vic Wahl immediately and voluntarily assumed the role of "Acting Chief of Police" while a search process for a permanent Chief was started by the PFC; and,

WHEREAS, as Acting Chief, Assistant Chief Wahl led the MPD with distinction, dedication and steady, calm leadership through some of the most difficult circumstances faced by the Madison community and the Madison Police Department; and,

WHEREAS, as Acting Chief, while he was navigating and leading the MPD through the COVID-19 pandemic, periods of civil unrest, ongoing difficult but critical community conversations about the role of police in our community, and an incredibly difficult budget process, he was also continuously preparing the department for an important transition to Chief Shon Barnes; and,
