**Fiscal Note**

The cost for the remainder of 2006 is approximately \$228 (or \$314, including benefits) and is available in the Comptroller's Office budget. The projected annualized cost is \$6,129 (or \$8,434, including benefits). The Comptroller's Office will fund the additional costs in 2007 through management of salary savings.
