DRAFTER'S ANALYSIS: This ordinance deletes the class of Monona Terrace Sales/Marketing/Events Manager in Compensation Group 19, Range 10, and creates the class of Monona Terrace Associate Director - Marketing, Events, Community and Public Relations in Compensation Group 18, Range 14.

The Common Council of the City of Madison do hereby ordain as follows:
