WHEREAS, VH 1000 Oaks, LLC, has satisfactorily completed the installation of sanitary sewer, storm sewer, and street improvements (including bituminous surface pavement) by private contract, in accordance with the City of Madison Standard Specifications for Public Works Construction, in: First Addition to 1000 Oaks Phase 2.

NOW, THEREFORE, BE IT RESOLVED

- 1. That said sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) be and are hereby accepted.
- 2. That said sanitary sewer improvements are hereby assigned to the Madison Sewer Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Sewer Utility's "Utility Plant In Service".

3. That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A" \$110,165.00.

- 4. That the street improvements, **excluding the bituminous pavement**, on the following streets be and are hereby accepted:
 - Gilded Cider Boulevard North from Gingergrass Way to Quiet Pond Drive
 - Gingergrass Way from 53' South of Watts Road to Gilded Cider Boulevard North
 - OL 4 Alley from Gingergrass Way to Quiet Pond Drive
 - Quiet Pond Drive from 100' South of Watts Road to Gilded Cider Boulevard North
 - South Point Road from 100' South of Watts Road to Gilded Cider Boulevard North (sidewalk only)

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 11500 \$152,582.17 for a useful life of 40 years.
