Fiscal Note

The proposed resolution reclassifies position #634 from CG20 Range 11 to CG20 Range 12. The cost of this reclassification for the remainder of 2017 is approximately \$642, including benefits. The cost will be absorbed within the Planning Division's 2017 Adopted Operating Budget. The annualized cost of this reclassification is approximately \$1,284, including benefits.
