- 1. That the bituminous surface improvements on the following streets be and are hereby accepted:
 - Catalina Parkway from the east line of Lot 41 to the west line of Lot 258.
 - Secret Garden Drive from Bautista Alley (existing street) to the north plat line.
 - · Arrowpoint Way from Secret Garden Drive to Bautista Drive.
 - Bautista Drive from Bautista Alley (existing street) to Catalina Parkway.
 - · Alley 'O' (Catalina Alley) From Secret Garden Drive to Catalina Parkway.
