**Fiscal Note**

In the adopted 2016 capital budget the Sewer Utility has budgeted \$2.305 million for the rehabilitation of failing sewers within the Trenchless Sewer Rehabilitation capital program (MUNIS 10450). The minor project for cured-in-place-piping (CIPP) improvements is established for the work specified in this proposed contract. Funding is provided by Utility reserves.

The proposed resolution approves plan documents at a total estimated cost of \$878,835. That total is comprised of \$788,325 for Sewer Utility improvements, and \$90,510 for Stormwater Utility improvements.
