#### **Fiscal Note**

The proposed resolution amends the 2020 Adopted Capital Budget for the Water Utility by authorizing a netneutral transfer of existing budget authority across various project and program budgets. The proposed resolution transfers budget authority from existing Water Main Replacement - Pavement Management, Water Main Replacement - Reconstruct Streets, Water Main Rehabilitation and Water Mains - New major program budgets into specific or standalone project budgets to better align with the corresponding projects in the Engineering budget. The resolution also transfers existing budget authority between specific projects to reflect scope adjustments and current water main replacement priorities.

The Water Utility 2020 Adopted Capital Budget will be amended to reflect the following transfers:

#### **Title**

Amending the 2020 Water Utility Capital Budget to transfer existing budget authority between various major project and program budgets to intended 2020 water main replacement projects.

#### **Body**

### PREAMBLE:

The adopted 2020 Water Utility Capital Budget allocated budget authority for several identified water main replacement and water main extension sub-projects within major project/program budgets. Additionally, Water Utility project scope was adjusted on several proposed 2020 water main replacement projects to allow for incorporating additional 2020 water main replacement priorities within other proposed 2020 public works improvement projects. This resolution transfers existing budget authority from the major project and program budgets into the intended sub-projects and/or stand-alone projects.

NOW, THEREFORE, BE IT RESOLVED that the 2020 Water Utility Capital Budget is hereby amended to transfer existing budget authority between major project and program budgets into stand-alone projects and/or minor projects, and transfer existing project budget authority between minor projects as described in the attachment, which is incorporated herein.
