WHEREAS, The City of Madison as a permitted municipal separate storm sewer system (MS4) by the WDNR and EPA is mandated to track and reduce pollutants to the Waters of the State including chlorides;

WHEREAS, Wisconsin Saltwise is a collation of members dedicated to the efficient use of winter deicers that contain chlorides.

WHEREAS, City Engineering, via the Storm Water Utility, has partnered with CARPC and multiple other groups and municipalities as part of a group known as Wisconsin Saltwise for the last six (6) years and

WHEREAS, Wisconsin Saltwise has realized a need for a limited term employee to help coordinate activities and continue to advance salt reduction efforts:

The Mayor and City Clerk are hereby authorized to execute Cooperative Agreement with CARPC for the
