Fiscal Note

The proposed resolution authorizes awarding Public Works Contract 8500 for the Martin Luther King Jr. Blvd. Sidewalk Assessment District - 2020 at a total cost of \$1,443,670 including contingency. Legislative File 59139, adopted by the Common Council on February 4, 2020, transferred \$510,000 of existing GO Borrowing to MUNIS account 11164-402-170, increasing the funding in that project to \$1,413,000. Sufficient budget authority for the proposed contract is included in the following MUNIS accounts. No additional City appropriation is required.
