**Title**

Amending Sections 37.05(4)(f) of the Madison General Ordinances to establish 2007 Storm Water Utility Rates effective January 1, 2007.

**Body**

DRAFTER'S ANALYSIS: This ordinance establishes the storm water utility rates for 2007.

The Common Council of the City of Madison do hereby ordain as follows:

Subdivision (f) entitled "Rate Structure" of Subsection (4) entitled "Rates and Charges" of Section 37.05 entitled "The Public Stormwater System" of the Madison General Ordinances is amended to read as follows:

- "(f) Rate Structure. Effective January 1, ~~2006~~ 2007, the following schedule of rates and charges shall be in effect:
- The Customer Charge for each six months shall be ~~\$3.20~~ \$3.35 for each lot or parcel of land.
  - The Impervious Area Charge for each six months shall be ~~\$7.09~~ \$7.44 per 1,000 square feet of Impervious Area.
  - The Pervious Area Charge for each six months shall be ~~\$0.495~~ \$0.52 per 1,000 square feet of Pervious

Area."
