AMENDED - Creating Section 8.24(1)(x) of the Madison General Ordinances to regulate the use of alcohol beverages in Law Park.

Body

DRAFTER'S ANALYSIS: This ordinance regulates the use of alcohol beverages in Law Park.

The Common Council of the City of Madison do hereby ordain as follows:

Subdivision (x) of Subsection (1) entitled "Prohibition" of Section 8.24 entitled "Alcohol Beverage Control And Container Control On Certain Public Property" of the Madison General Ordinances is created to read as follows:

"(x) In any part of Law Park except in duly designated and cordoned off areas specifically set aside for the

consumption of alcohol beverages or in other areas, with the prior approval of the Parks Division <u>provided, however, that this subdivision shall be ineffective after December 31, 2008.</u>"
