WHEREAS, access to comprehensive reproductive health care-including pap smears, mammograms, treatment for sexually-transmitted infections, and birth control-is critical to the overall well-being of women and their families; and,

WHEREAS, women's health care providers have saved countless lives by preventing and treating lifethreatening diseases including breast, cervical, and ovarian cancers, and HIV-AIDS; and,

WHEREAS, family planning is recognized by the US Centers for Disease Control and Prevention (CDC) as one of the top ten public health achievements of the 20th century; and,

WHEREAS, the City of Madison values the many licensed health care professionals who provide this basic care in a compassionate setting, at times under threat of violence; and,
