**Fiscal Note**

The proposed grant provides for \$45,000 in funding. The required City matching funds of \$15,000 will be requested in the 2007 Traffic Engineering capital budget.

**Title**

Accepting grant monies in the amount of \$45,000 from the Wisconsin Department of Transportation for the installation of epoxy pavement markings.

**Body**

**WHEREAS**, the City Traffic Engineering Division recognizes the importance of providing for safe, durable and highly visible epoxy pavement markings for crosswalks and roads (intersections, curves, and hills).

**WHEREAS**, the Wisconsin Department of Transportation administers the Traffic Signing and Marking Enhancement Grant program and has approved a project for the City of Madison in the amount of \$60,000, of which \$45,000 of State grant monies will be matched by \$15,000 of City funds, to install epoxy pavement marking at several locations.

**NOW, THEREFORE, BE IT RESOLVED** that the Traffic Engineering Division be authorized to accept grant monies in the amount of \$45,000 from the Wisconsin Department of Transportation to install epoxy pavement markings at several locations.
