#### Title

To suspend the Class B Combination alcohol beverage license granted Mad City Restaurant Group, Inc., d/b/a Quinton's Bar & Deli, 319 W. Gorham Street, Madison, WI 53703.

## **Body**

WHEREAS, a complaint was filed by Assistant City Attorney Steven C. Brist alleging a single count of alcohol beverage violations at the premises known as Quinton's Bar & Deli, 319 W. Gorham Street, Madison, Wisconsin and operated by the Mad City Restaurant Group, Inc.; and

WHEREAS, pursuant to Sec. 38.10 of the Madison General Ordinances, Assistant City Attorney Steven C. Brist and Mad City Restaurant Group, d/b/a Quinton's Bar & Deli, through their attorney, Rick Petri, entered into a post-hearing stipulation regarding disposition of the subject complaint. The disposition includes a three (3) day suspension of Quinton's Bar & Deli's Class B Combination Alcohol Beverage license; and

WHEREAS, the Alcohol License Review Committee (ALRC) conducted a hearing and thereafter received the stipulation of the parties, the ALRC issued an Order that recommended approval of the three (3) day suspension of Quinton's Bar & Deli's Class B Combination alcohol beverage license but imposed said suspension on different dates than that recommended in the Stipulation to wit, a suspension period beginning at 2:30 AM on Thursday, July 17, 2008 and ending at 2:30 AM on Sunday, July 20, 2008; and

WHEREAS, that during the period of suspension recommended in the ALRC Order Mad City Restaurant Group, d/b/a Quinton's Bar & Deli will be able to operate its restaurant business; and

NOW THEREFORE, BE IT RESOLVED, that the Common Council accepts the stipulation of the parties as that
