SECOND SUBSTITUTE - Amending Section 8.18(2) of the Madison General Ordinances extending the length of time parking is allowed at the Brittingham Boathouse, Bathhouse and Shelter.

DRAFTER'S ANALYSIS: This ordinance corrects the language in the body of the ordinance to match the original intent extending the length of time parking is allowed at the Brittingham Boathouse, Bathhouse and Shelter.

The Common Council of the City of Madison do hereby ordain as follows:

Subsection (2) entitled "Parking Regulated at Brittingham Boathouse, Bathhouse and Shelter" of Section 8.18 entitled "Parking Regulated in Certain Parks" of the Madison General Ordinances is amended to read as follows:

- "(2) Parking Regulated at Brittingham Boathouse, Bathhouse and Shelter.
 - (a) No person shall park, stop or leave standing any vehicle at the Brittingham Boathouse parking lot or the Brittingham Shelter parking lot whether attended or unattended, for more than three (3) hours between 8:00 a.m. and 4:005:00 p.m., holidays excepted.
 - (b) No person shall park, stop or leave standing any vehicle at the Brittingham Bathhouse parking lot whether attended or unattended, <u>for more than five (5) hours</u>, <u>during the months of June</u>, <u>July and August</u>, <u>for more than three (3) hours</u> between 8:00 a.m. and 4:005:00 p.m. Monday through Friday, holidays excepted."
