The proposed Amendment to the Agreement with Black and Veatch Corp. for the East Side Water Supply Planning and Project Development will not exceed \$28,000. Total contract value will be increased to \$578,000.

WHEREAS, in 2010 Madison Water Utility Water contracted with Black and Veatch to conduct a comprehensive east side water master planning study; and

WHEREAS, a major portion of that effort included a comprehensive public participation engagement process; and

WHEREAS, during the commencement of the work it quickly became obvious that the Citizen's Advisory Panel required additional meetings and coordination effort resulting in a total of over 40 public meetings over the course of 8 months; and

WHEREAS, Black and Veatch Inc budgeted \$93,691 for the project public participation process and actual costs were approximately \$129,000; and

WHEREAS, savings were realized under other project tasks; and

WHEREAS, Madison Water Utility agreed to the increase in public participation effort and directly realized the benefits to the comprehensive effort; and

WHEREAS, the recommendations resulting from this process were unanimously received and approved by the Water Utility Board;

NOW THEREFORE BE IT RESOLVED that the Mayor and the City Clerk are authorized to execute Amendment No. 1 to the Professional Services Agreement with Black and Veatch Corporation for the "East Side Water Supply Planning and Project Development" project not to exceed \$28,000 bringing the total value of the East Side Water Supply Project to \$578,000.
