## **Fiscal Note**

The proposed resolution approves the creation of two new CG-RG levels and reclassifies position #2785 from CG43-RG12 to CG43-RG14. The annualized cost of this reclassification is \$4,464 including both salaries and benefits. For the remainder of 2016 the cost of the reclassification is \$900. This cost will be absorbed within Metro's operating budget.
