The proposed resolution authorizes plan documents for the planned improvements within the 2018 Bikeways program. The estimated cost of the bikeway improvements is \$900,000; Engineering Pedestrian and Bicycle has budgeted \$781,000 of GO Borrowing in 2018 in addition to carry forward appropriation from 2017 to sufficiently fund the proposed improvements. Funding for this program is provided by GO Borrowing.
