**Fiscal Note**

In the adopted 2016 capital budget the Engineering Ped-Bike division has budgeted \$680,000 for bicycle related improvements throughout the city under their Bikeways Program (MUNIS 10138). A minor project under this program is for the improvements for the Demetral Park path (MUNIS 10460). Additionally, the Parks division has budgeted for components of the Demetral Park improvements (MUNIS 10465). Funding is from GO borrowing.

The proposed resolution awards the specified contract at an estimate cost of \$362,230.
