Fiscal Note

The additional wage expense in 2014 is an estimated \$980, plus \$353 for fringe benefit expense, or a total additional expense of \$1,333. The Parking Utility will manage its salary savings in 2014 to accommodate the additional expense, so no additional appropriation is required. The full, annualized future expense (at Step 5) is \$3,666 for wages, plus \$1,320 for fringe benefits, or a total expense of \$4,986, which will need to be included in future operating budgets, subject to Common Council approval.
