Accepting sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) constructed by Private Contract In Woodstone Replat - Phase I, Private Contract No. 2257.

**Body**

WHEREAS, Pheasant Ridge, LLC has satisfactorily completed the installation of sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) by private contract, in accordance with the City of Madison Standard Specifications for Public Works Construction, in: Woodstone Replat - Phase I.

NOW, THEREFORE, BE IT RESOLVED

1. That said sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) be and are hereby accepted.
2. That said sanitary sewer improvements are hereby assigned to the Madison Sewer Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Sewer Utility's "Utility Plant In Service".

3. That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A"      \$230,158.34

4. That the street improvements, **excluding the bituminous pavement**, on the following streets be and are hereby accepted:

- Spirit Street from the west plat line to the east plat line.
- Little Bear Drive from the south line of the public alley (north line of Lot 35) to Elderberry Eoad.
- Fargo Trail from the south line of the public alley (north line of Lot 45) to Elderberry Road.

5. That the public alley on the following streets be and are hereby accepted:

- Public alley from Little Bear Drive to Fargo Trail.

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 53B2257 \$ 386,406.36 for a useful life of 40 years.
