Fiscal Note

The annualized cost of the proposed reclassification is \$27,610 (including benefits). The impact on the 2020 budget is approximately \$13,805. Traffic Engineering's second quarter projection has an overall projected deficit of approximately \$115,000 with a deficit in salary and benefits estimated at \$87,000. Traffic Engineering will likely need a 2020 operating budget amendment to cover the projected salary and benefits deficit in FY 2020, notwithstanding the proposed recreation of position #624.

Title

Delete the classification of Storekeeper in CG16, R11, and create a new classification of Storekeeper in CG16, R12. Recreate position number #1201 to a Storekeeper (CG18, R12), and reallocate incumbent E. Smith into the new position in the Traffic Engineering operating budget.
